To Whom It May Concern:

The California Fisheries Coalition (CFC, the "Coalition") is a subsidiary organization operating under the auspices of the Alliance of Communities for Sustainable Fisheries (ACSF, the Alliance), tax ID number 72-1582491, effective December 16, 2004.

The Alliance is a 501(c)(3) public charity and a non-profit corporation incorporated in the State of California, effective December 16, 2002. The purpose of ACSF is to preserve the heritage and enhance the economic value of fishing to California coastal communities. It does this by ensuring that the best oceanographic, socio-economic, and fishery science is accurately compiled, that this science is readily available for use in crafting public policy, and by ensuring the public understands the link between healthy sustainable fisheries, marine conservation, and coastal communities.

The California Fisheries Coalition is an informal organization consisting of recreational and commercial fishing entities working together to ensure cleaner oceans and sustainable marine resources. The CFC is undertaking a program to ensure the broad interests of recreational and commercial fishing organizations are equitably represented in the creation of Marine Protected Areas within the State. As such, the CFC is a program supported and overseen by the ACSF.

While the CFC is guided by a Committee of Trustees (its decision making body) its work is reviewed by and its financial records are included in those of the ACSF. A member of the ACSF Board sits as a member of the CFC Trustees. CFC actions will be consistent with the mission of the Alliance.

The CFC is authorized to solicit, receive and expend money in pursuit of its purposes and the CFC Manager is authorized to maintain accounts, receive and disperse funds, and enter into agreements in behalf of the Coalition's business, consistent with guidance from the CFC Trustees.
